Anent the reference (1) cited, I wish to state that the Board of Engineers in their 460th meeting held on 18.05.07 have discussed in detail and after elaborate deliberation the Board have decided to recommend the name of **Thiru B.S.Vijayakumar** for inclusion in the panel of private practicing Engineers under Class IA (one A) category (**the value of Building works cost exceeds more than Rs. 30.00 lakhs**) in Thiruvallur District.
